Dear Friends,

we all know that there is an intimate and inseparable relationship between periodontal health and dental restorations. However, several factors can alter, sometimes irreversibly, this state of health: some depend on anatomical factors, others may be related to restoration; some depend on the gingival phenotype, others are linked to the maturation of tissues following a surgical intervention.

The role of the Dental Hygienist is and remains to help preserve the state of periodontal health and to involve the patient in this operation: but how do we behave when there is a restoration? Is the type of restoration important, or is it indifferent? Regarding the location of the pre-existing lesion, it is indifferent or is there a need to change dental hygiene techniques? Only the professional or even home care ones?

To this and other similar questions of daily recognition we will try to give an answer taking into account that, sometimes, literature is not completely clear in the conclusions highlighted. However, the goal to achieve remains the maintenance of periodontal health in order to obtain the best possible prognosis for the teeth and for the restorations placed on them: these factors are conditioning each other.

Each session will include a lot of interaction with the formulation of specific questions also during the presentations, to end with an interactive discussion that will involve and surely thrill us.

We believe this will really be a moment of not renounceable training and experience.
