“Claudio Cevenini” Award 2024 for the best clinical case of non-surgical periodontal therapy

RESERVED TO DENTAL HYGIENISTS

The **Italian Society of Periodontology and Implantology** has established an annual Award since 2021, reserved for its **Dental Hygienist Members**, to honor the memory of the active member **Claudio Cevenini**, prematurely died, who has always supported the primary role of the Dental Hygienist for periodontal and oral health. within a professional team based activity. The goal of this Award is to even more involve our Dental Hygienists Members in the various activities of SIDP, through the presentation of a clinical case, in a **dedicated space (Clinical Forum) within the 2024 Annual Congress** of the Society (Rimini I, 21-23 March).

The **clinical case** should concern the treatment with non-surgical therapy of a case of periodontal disease. The **abstract**, written in Italian or English, must contain a brief description of the clinical case that includes, in addition to the diagnosis defined by the dentist with whom the hygienist collaborates, also the objectives of the treatment, the description of the timing, the strategies used to correct lifestyles and the evaluation of the results obtained in the medium to long term. The abstracts must be sent by **February the 16th 2024** using only the appropriate **electronic form** available on the website www.sidp.it (Competitions and Awards section).

The works deemed more deserving and accepted (up to a maximum of ten) will be presented and discussed by the participant in front of the Evaluating Committee (composed by the Coordinators of the 2024 Clinical Forum and by a member of the SIDP Executive Council) and Colleagues, with a presentation lasting a total of fifteen minutes, including discussion. The presentations will be judged on the basis of the iconographic quality of the documentation, organization of presentation and ability to answer the questions posed to the candidate.

The other works received for participation in the awarding of the Prize may be presented as *Poster* again as part of the Society 2024 National Congress.

The explanatory iconographic material of the clinical case must be organized - in Italian or English - in **presentation format (PPT or Keynote)** following the indications given below.

The **presentation file** must be **sent to the Society Secretariat** using automatic file sharing and transfer systems via web such as:

The SIDP Secretariat will send it to the Coordinators of the 2023 session of the Clinical Forum-Claudio Cevenini Award, for the evaluation of acceptance.

Notification of acceptance or not will be sent by e-mail by February the 28th 2024.

The Evaluating Committee will have the task of evaluating the most deserving presentation to receive the Award, consisting of free registration in the SIDP for one year and publication of the clinical case at the Society's website www.sidp.it.

The **announcement of the winner** will officially take place during the final day of the SIDP Annual Congress 2024.

Suggestions and tips for selecting photographic documentation

The explanatory iconographic material of the clinical case must be organized in presentation format (PPT or Keynote) following the suggestions below but in any case it cannot exceed 16 slides overall.

- **Clinical and Radiographic situation:**
 1. Overview showing the general clinical situation of the patient classification in the first visit made by the dentist
 2. Initial clinical images of the different sextants to be treated with buccal, occlusal and lingual vision
 3. Complete periodontal probing
 4. Intraoral radiography
 5. Periodontal diagnosis (by the dentist)
 6. Definition of objectives
- **Non surgical therapy:**
 1. Description of the operative modalities and timing
 2. Particularly significant preoperative clinical images of some specific sites
 3. Possible intraoperative images
- **Treatment results:**
 1. 1. Short-term healing (6-8 weeks) with post-operative clinical images with an overview, sextants views and comparison with the images preoperatively performed in some specific sites
 2. Complete periodontal probing
 3. Periodontal re-evaluation, definition of the risk profile and the frequency of supportive therapy (by the dentist)
- **Follow-up:** (minimum 6 months)
 1. Overview of the mouth and sextants for comparison with short-term preoperative and postoperative images
 2. Complete periodontal probing
 3. Intraoral radiographic status (if at least 2 years of follow up have passed)
 4. Periodontal re-evaluation, risk profile and frequency of supporting periodontal therapy (by the dentist)

The maximum number of slides allowed is 16. No more than 6 clinical images can be used for each slide.
